4. CONSIDER CONSTRUCTION OF A TRAILS SYSTEM UPON CITY PROPERTY KNOWN AS FULLER PARK, SOUTH 8TH STREET, AND WATER TOWER PROPERTY, WITH SUCH IMPROVEMENTS TO BE OWNED AND MAINTAINED BY THE CITY, SUBJECT TO A GROUP OF CITIZENS RAISING SUFFICIENT FUNDS FOR CONSTRUCTION OF THE IMPROVEMENTS

Clerk Devine explained this was previously approved, however, the Nebraska Community Foundation required additional language clarifying who would be responsible for maintenance of the recreational trail on this property.
